IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement PRUCO RECENTLY TERMINATED ME BECAUSE ITS UNDERWRITERS DID NOT COLLECT COMPLETE INFORMATION REGARDING THE MEDICAL HISTORY OF ONE OF MY CUSTOMERS BEFORE IT ISSUED A POLICY TO HIM. IT WAS NOT MY RESPONSIBILITY TO COLLECT MEDICAL HISTORY FROM CUSTOMERS AND PROVIDE IT IN SUPPORT OF THE APPLICATION. RATHER, THIS WAS EXCLUSIVELY PRUCO'S UNDERWRITERS' JOB. MY JOB WITH PRUCO WAS TO HELP MATCH THE CUSTOMER WITH A SUITABLE LIFE



INSURANCE PRODUCT. MY JOB WAS NOT TO MANAGE OR EXECUTE THE UNDERWRITING PROCESS. PRUCO MADE ME THE SCAPEGOAT FOR THE ERRORS OF ITS UNDERWRITERS AND SUPERVISORS. I DID ABSOLUTELY NOTHING WRONG: I DID NOT COMMIT FRAUD, TAKE ANY PROPERTY, OR VIOLATE ANY SECURITIES INVESTMENT-RELATED RULES. I WAS NOT EVEN IN A POSITION TO DO SO, BECAUSE I WAS NOT RESPONSIBLE FOR ANY PART OF THE CUSTOMER APPLICATION OR UNDERWRITING PROCESS. I HAVE NEVER BEEN ACCUSED OF ANY WRONGDOING BY EMPLOYERS OR CUSTOMERS IN MY LIFE, AND I ABSOLUTELY DENY THAT I DID ANYTHING WRONG. THERE IS NO BASIS FOR PRUCO'S CLAIMS HERE. WHEN PRUCO INVESTIGATED THE ALLEGATIONS FOR WHICH I WAS ULTIMATELY TERMINATED, THEIR INVESTIGATORS HAD NO INTEREST IN HEARING MY SIDE OF THE STORY.

WHEN I ASKED FOR DOCUMENTATION PROVING THAT I DID ANYTHING WRONG, PRUCO DID NOT HAVE THE DOCUMENTATION. I AM AN ASIAN WOMAN WHO WAS NOT PROPERLY TRAINED OR SUPERVISED AT PRUCO, AND I BELIEVE THAT THE ALLEGATIONS ARE PRETEXTUAL, AND THAT THE ISSUE WITH THIS CUSTOMER'S RECORDS WAS NOT THE REAL REASON THAT PRUCO TERMINATED ME. PEOPLE SHOULD BE AWARE THAT THERE IS NO "DUE PROCESS" BEFORE EMPLOYERS LIKE PRUCO CAN MAKE DEFAMATORY ALLEGATIONS ON BROKER CHECK LIKE THE ALLEGATION ABOVE. I WAS NEVER ALLOWED TO PRESENT MY SIDE OF THE STORY. IT IS A TRAVESTY OF JUSTICE THAT COMPANIES LIKE PRUCO CAN BLAME ME AND OTHERS OF THEIR REGISTERED REPRESENTATIVES FOR THE COMPANY'S OWN MISTAKES, AND OUR CAREERS ARE HARMED WHILE BUSINESS CARRIES ON AS USUAL AT PRUCO. THE ALLEGATION THAT YOU SEE ABOVE IS SIMPLY PRUCO'S UNFOUNDED, UNSUPPORTED CLAIM. THEY HAVE NO EVIDENCE FOR WHAT THEY SAY. I AM IN THE PROCESS OF SUING PRUCO FOR DEFAMATION AND WRONGFUL TERMINATION, AND AM DISPUTING THE ALLEGATIONS ABOVE WITH FINRA.
