IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: MWA Financial Services, Inc.

Allegations: Representative was named in a civil litigation in which an insurance agent of whom the representative supervises replaced a fixed indexed annuity with a single premium immediate annuity (SPIA). This occurred around 02/2017. Customer passed away in 06/2017. The insurance agent who conducted the business is not associated with the firm in any capacity, and is associated with the firm's parent company in a part-time capacity.

The litigation alleges the insurance agent replaced a fixed indexed annuity valued at \$613,000 with a SPIA that cost \$525,000. The litigation alleges the surrender fees were \$90,000 on the initial annuity. The litigation alleges client received monthly payments from the SPIA totaling \$22,500 before his passing.

The civil litigation names the representative as a defendant because he serves in a supervisory capacity over the insurance agent. The litigation alleges the following against all defendants including the representative: violation of California Insurance Code, violation of NAIC suitability rules, misrepresentation, churning, financial elder abuse, breach of fiduciary duty, breach of contract, breach of implied covenant of good faith and fair dealing, willfully and intentionally engaging in fraud and deceit, negligent misrepresentation, unfair business practices and competition, false advertising, and unjust enrichment.
