### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

#### Broker Statement

This matter pertains to a personal credit card issued by JPMorgan Chase. The account was not paid on time due to an unexpected disruption in the automatic payment arrangement. The card was utilized exclusively for legitimate business expenses related to an established sign company and was not associated with any investment-related activities. The automatic payment was intended to be processed from a designated business account; however, it was canceled by a business partner without my knowledge or authorization. Upon becoming aware of the situation, I promptly contacted the creditor and successfully negotiated a payment agreement to resolve the outstanding balance.
