**Broker Statement**

During my time at Schwab, an administrative review addressed documentation of an introductory meeting that was handled by my junior advisor. The notes were maintained for internal reference only and were not public. I later followed up directly with the client, and no accounts were affected.

The CFP Board reviewed the matter and chose not to take any action, and there were no regulatory actions taken by FINRA. This confirmed that the issue was



procedural in nature and not a significant concern.

This experience helped me strengthen my documentation and communication processes to ensure transparency and accuracy in all client interactions. My focus continues to be providing fiduciary, client-first financial planning and helping clients pursue their long-term goals.
