<b>Sentence/Penalty:</b>	On 05/15/2013, I pled guilty to a misdemeanor only to have a deferred adjudication to be filled and granted by the court. They put me on a two year unsupervised probation from (05/15/2013) to (05/15/2015). If I completed the probation, my misdemeanor would become a no conviction. I completed my two year unsupervised probation on (05/15/2015).
<b>Broker Statement</b>	I was originally charged with a felony on 9/23/2012, but my lawyer started to negotiate with the state until he made a deal with the state in May of 2013. On 05/15/2013, in court, I pled guilty to a misdemeanor only to have a suspended imposition of sentence filled and granted in court. This means that if I completed my two year unsupervised probation from (5/15/2013) to (5/15/2015), that there would be no conviction or record. I completed that two year unsupervised probation on (05/15/2015).
