IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: BANORTE SECURITIES INTERNATIONAL, LTD. (ORG ID: 30648)

Allegations: The customer was upset because the registered representative was not clear when he requested information on the amount of interest he received on his US Treasury investments. The Firm's Head of Sales contacted the customer on two occasions, September 11, 2024, and September 17, 2024. During these conversations, it was explained, among other items, that our Firm charges a reasonable markup when offering US Treasury securities, and the yield could vary depending on the mark-up charged. These are being disclosed on each trade confirmation that the customer receives. To reiterate the Firm's commitment to conducting business in a transparent and fair manner, we have taken the necessary steps to reverse the mark-up charged in the amount of \$20,043.38 on these nine US Treasury transactions, purchased in two accounts the customer has with the firm, for purchase dates ranging from October 2023 through August 2024. Revised confirmations have been provided to the customer, along with the Firm's written response, on September 18, 2024.
