IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: Bankers Life Casualty & Company and Bankers Life Securities, Inc.

Allegations: In a written complaint, addressed to Bankers Life and Casualty Company (BLC), an insurance company affiliate of the Firm, a copy of which was received by the Firm on December 12, 2018, [REDACTED] alleged the Guaranteed Life Income Annuity (GLIA) she purchased from BLC in August of 2017 was unsuitable based on an incorrect assertion regarding product liquidity. [REDACTED] also alleged that registered representative, Brock Williams, did not provide a copy of the policy, resulting in her being unable to cancel her policy under the "free-look" period. [REDACTED] asked for the policy to be rescinded. While the GLIA sold to [REDACTED] was not a security and was issued by BLC, the Firm is reporting this complaint because the source of funding for the BLC annuity came from the sale of securities recommended by a registered representative of the Firm. BLC determined that the purchase of the GLIA was suitable for the client, that the client was provided the policy and signed an acknowledgement of receipt on October 3, 2017, and did not exercise her rights to cancel the policy during free look which expired 30 days thereafter.
