### What is included in a IAPD report?

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement**

On April 27, 2012 the client verbally complained to Investment Advisor and Branch Manager claiming that the ROI High Income Private Placement Fund Series F purchased in the client's account at RBC Dominion Securities Inc. on September 7, 2011 was not suitable and that the client had requested a GIC instead. It was determined that Investment Advisor should not have recommended the purchase of ROI. As a result the position was removed from the client account. A settlement in the amount of CAD\$70583 was credited to the client's account of which CAD\$70,000 is the book value of the investment and CAD\$583 is the interest on the investment.
