IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

What you should know about reported disclosure events:

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement	After extensive due diligence on this program, including having two legal opinion letters wherein securities attorneys opined the program was not a security, the SEC subsequently took a different position and deemed it to be a security. The



Desist and Refrain Order, issued by the state level governing agency, ordered me to stop selling an unregistered security. There are many allegations in the "Order" that are untrue, which are supported by additional documentary evidence available for review. In addition, as a licensed California attorney, I was completely exonerated by the California State Bar on this matter, and I have never had any client complaints against my law license, or insurance licenses, or in my capacity as a Charter Financial Consultant (ChFC) and Chartered Licensed Underwriter (CLU). I also appealed this matter to the California Court of Appeals, but was precluded from proceeding because the one year statute of limitations had expired.
