**Allegations:** Without admitting or denying the findings, Erwin consented to the sanctions and to the entry of findings that he settled a customer complaint without the knowledge or approval of his member firm. The findings stated that the customer instructed Erwin to close her account by a certain date. Erwin did not close the customer's account until seven days later, by which time the account had declined in value. Shortly thereafter, the customer contacted Erwin and his branch office administrator to complain. Erwin wrote the customer a personal check for \$2,500 to settle the complaint. Although the firm was aware of the customer's complaint, Erwin did not disclose to the firm that he had paid money to the customer to settle the complaint.
