<b>Allegations:</b>	Without admitting or denying the findings, Schumaker consented to the sanctions and to the entry of findings that he permitted and enabled a former registered representative who had been barred and statutorily disqualified from the securities industry by FINRA to conduct a securities business. The findings stated Schumaker knew the registered representative had been barred from the securities industry but allowed him to attend in-person customer meetings to discuss brokerage account strategy, email with customers about their brokerage account statements, maintain an office within Schumaker's branch location, and share a phone line with the branch location. Schumaker's former firm conducted two branch office audits and found the registered representative on the premises both times. After the first audit, the firm warned Schumaker that the registered representative could not be on premises, use a conference room on the premises, or provide him with any investment advice relating to brokerage accounts. Schumaker confirmed he understood. Nevertheless, when the firm performed a second audit, it found the registered representative in a meeting with Schumaker and a brokerage customer in the conference room.
