I lost my job as an FA in 08/2023, at which point I was suffering from [REDACTED] health issues, and due to disparaging remarks made on my U5 by my previous employer, I was finding it very difficult to find a comparable position. In the meantime it was a full time job to manage my health and medical bills were mounting. I took paid medical bills on credit cards, then took out loans to pay the bills while I was still working and could no longer make payments. I was denied for disability. I had to take a job making about 50% of what I was because we needed income to pay our mortgage, and I couldn't work a full time job due to my health. Debt and bills snowballed and in order to save my house and my car I filed bankruptcy. Because of my husband's income I didn't qualify for chapter 7. Then we received a substantial financial gift and I was able to pay off some of the debt, so before the bankruptcy was confirmed I withdrew it.
