What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Employing firm when activities occurred which led to the complaint: NYLIFE SECURITIES LLC

Allegations: Customers alleged that they were misled in connection with the purchase of two variable universal life insurance policies for their children in May 2023 and that the policies did not meet their stated goals and need for cash flow. In January 2026, the customers contacted NYLife Securities requesting the return of their principal without surrender charges. Although Joel Chouinard participated in the sales process along with another agent, neither he nor the other agent were named in the customers' written complaint. Mr. Chouinard denies the allegations and states that the customers were provided written disclosures describing the product features, fees, and surrender charges prior to the purchase. The customers acknowledged their decision to proceed with the policies. To avoid the costs of further proceedings, NYLife Securities agreed to settle the matter for \$8,224. Mr. Chouinard did not contribute to the settlement and was not involved in the firm's decision to resolve the matter.
