### **What is included in a IAPD report?**

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### **Where did this information come from?**

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

**Allegations:** On 4/19/2024, the claimant's savings account was compromised and \$120.00 was misappropriated by a bad actor. His investment account was compromised on 4/23/2024, and \$1600.00 was misappropriated by a bad actor. Also on 4/23/2024, the claimant's brokerage account was used to purchase Nvidia stock. The claimant did not agree with SoFi's handling of his fraud claims. The claimant was seeking restitution and damages in the amount of \$3820. The registered representative had limited interaction with the claimant for account service purposes only, and was not involved in the account activity in question or the subsequent investigation process.
