IAPD Information About Representatives

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: The IAR engaged in activities that initially gave the firm cause for concern. However, upon completion of the firm's investigation, it has been determined that permitted resignation was a more appropriate response to the IAR's activities.

Allegations: The firm's initial investigation found evidence of investing in and subsequently lending money to a real estate development entity owned by existing clients; and soliciting clients and non-clients to purchase real estate in the development without disclosing the IAR's ownership in the company or other conflicts of interest. Mr. Miller disputes the termination and has filed arbitration against the company, its CEO, and its Chief Compliance Officer (CCO) for defamation, wrongful termination, breach of contract, and theft of my ownership interest in the company. The "allegations" the company has made public are not the reason that the company terminated Mr. Miller. The company failed to disclose is that Mr. Miller was leaving the company at the time and sought to sell back his ownership/membership interest.
