What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: CV Securities Analysis, LLC ("CVSA") relocated from the state of Georgia to the State of Tennessee in June of 2021. CVSA did not register as an investment advisor in the State of Tennessee until August of 2021, during which time investment management fees were charged and collected. Upon receiving notification from state regulators, CVSA ceased operations and provided all information requested related to the inquiry. A civil penalty of \$1,000 was charged by the Tennessee Securities Division and paid by CVSA on November 16, 2021. CVSA was informed that the outstanding application as a Registered Investment Advisor in the State of Tennessee would be approved after the matter had been settled, including payment of the aforementioned civil penalty.

Allegations:	CVSA relocated from the State of Georgia to the State of Tennessee in June of 2021. Registration with the state of Tennessee did not occur immediately and thus CVSA was found to be operating as an unlicensed investment advisor in the state. The period of operation in the State of Tennessee without proper registration lasted from June through August of 2021, during which time CVSA collected fees for investment management services. A civil penalty of \$1,000 was imposed and paid by CVSA before approval of registration in the new state was finalized.
