### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement** At the age of 17, I solicited my mother to purchase alcohol for me to bring to a party that was hosted at a friend of mines house whose mother had permitted us to do so. I had accompanied my mother into the liquor store in which she purchased a bottle of vodka for my use and consumption. At this point, I then brought the alcohol to the party which was populated with 20-30 other peers of mine who also



had brought alcohol. My girlfriend and I had left the party that night and the next morning were awoken to a friend's mother asking us to come back to the house where the party was held as she felt there was someone deceased in her bedroom. When we arrived back to the house, it was confirmed that the individual was deceased and at that point we called an ambulance.

After several weeks of deliberation, an indictment came down on me, my mother and the lady who hosted the party at her house. The reasoning for my arrest was based on the D.A.'s notion that by my mother buying me alcohol and me being the vessel to which the alcohol was provided at the party, there was a direct role of responsibility as a component to the individual's death by alcohol poisoning. Never minding that several others that were at the party also provided alcohol as that could not be proven so easily as it was to prove our contribution of alcohol due to the fact that the liquor store surveillance camera showed my mother and I in the liquor store and forensic was able to lift the finger prints from the same vodka bottle found in the trash which linked back to my mother and I.
