IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	I deny any claims of unsuitability in connection with this customer complaint and its



resolution. The claim in fact was related to an apparent misunderstanding or miscommunication between the power of attorney (agent) on the account and the actual account owner. An associate banker covering this client while I was on pregnancy leave of absence recommended a particular mutual fund to the agent because of a request for additional yield on cash sitting in the client account. After the mutual fund was purchased- at the agent's direction- the account owner saw a decrease in the value of the mutual fund, and subsequently directed that the mutual fund in question be sold. The firm ultimately determined that an accommodation for this client would be appropriate. I neither contributed to this client accommodation nor was asked by the firm to so contribute.
