IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

**Broker Statement**

On May 31st, 2024, [REDACTED] representative, Stoel Rives LLP, sent a letter to the Retirement Solution LLC demanding payment. Per the letter, Stoel Rives LLP stated [REDACTED] would be able to establish claims for negligence, breach of contract, and/or breach of fiduciary duty against Respondents, which include Shane Perry.

The claim was regarding items that were acted on by the Respondents. By not taking into consideration [REDACTED] current tax liability, the two withdrawals processed from pre-tax accounts the same year as the selling of her home caused a higher tax liability.

After much deliberation, and to avoid risks, uncertainties, and cost of litigation, both parties agreed to settle and permanently resolve all claims that [REDACTED] has or may have against the Respondents. Per the signed Settlement Agreement, TRS paid [REDACTED] \$12,500.00.
