IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

*I helped an existing client with a new application for a fixed annuity (1035 exchange); one of the questions asked, "Does the client have any existing annuities? I made a typo and marked the check box, "No".

*Back office asked me to correct the error and re-submit, which I did. I went into the Annuity portal system, EBIX, changed the check box answer to "Yes", printed the page and re-submitted. There were 8 pages in the paper work, this was page 4 of 8 and was a non-signatory page.



*Months later compliance said that because I didn't have the client re-sign the entire package again (page 8 of 8) that it was a potential document integrity issue and I was "permitted to resign". The instructions on how to appropriately "correct" the original annuity paperwork were unclear at best, I would never intentionally alter a client document.
