IAPD Information About Representatives

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement**

IAR denies all claims. At our initial meeting, I gathered information on [REDACTED] retirement assets and his other investments. In a follow-up meeting to discuss his options, I relayed that we would use a money manager that utilizes a proactive, tactical approach. He decided to utilize this manager with assets custodied at T.D. Ameritrade. For safer options, I showed [REDACTED] several different fixed annuity options. We explored annuities for both guaranteed income and the three best accumulation products. He stated that he felt his income was sufficient. As [REDACTED] stated in his own words, "This is hands off money" and I stated, "This is not a checking account". We both agreed that the F&G Power Accumulator 10 was the best option. I proceeded to show him the surrender schedule in years 12,11,10,9,8,7,6,5,4 & 3. I also explained to him that after the first year, he could withdraw 10 percent of the accumulated value with no penalty. He said that would be fine because he had over \$150,000 still liquid between IRA and NonQualified funds. I met with this client two additional times and he did not express any concern about his investments. I strive to keep my clients informed and try to ensure that they are in the best position for their retirement.
