### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

**Broker Statement**

The matter was settled by Consent Order in which Trutta Capital, Inc. and Glenn Bossow, Trutta Capital's investment advisory representative, were ordered to desist and refrain from engaging in investment adviser activities for compensation in the State of California unless and until they have first applied for and secured from the California Commissioner a Certificate, then in effect, authorizing them to do so, unless exempt.
