ALL MUTUAL FUNDS IN THE CLIENT'S ACCOUNTS WERE APPROPRIATE BASED ON HER STATED RISK AND OBJECTIVE PROFILE. ALL MUTUAL FUNDS WERE AGREED UPON WITH THE CLIENT PRIOR TO TRADES TAKING PLACE.
