What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

ACTUAL COMPENSATORY DAMAGES OF \$2,707.91 WERE AWARDED AGAINST FIRM, THE OTHER BROKER, AND FC, JOINTLY AND SEVERALLY. FIRM PAID DAMAGES AWARD. FC WAS NOT REQUESTED TO CONTRIBUTE TO THAT PAYMENT.

FC, AS BROKER OF DAY, FIRST MET CLIENT ON 11/1/90 FOR SOLE PURPOSE OF ASSISTING HER TO TRANSFER HER ACCOUNT TO FC FROM ANOTHER BRANCH. THE ALLEGED UNAUTHORIZED TRADE THAT FORMED THE BASIS OF CLIENT'S CLAIM OCCURRED TWO MONTHS BEFORE FC AND CLIENT HAD ANY CONTACT, AND WHILE CLIENT WAS A CUSTOMER OF THE OTHR BROKERS. ONE WEEK

AFTER 11/01/90 MEETING, FC SAID THE SECURITY UNSOLICITED ON THE ADVICE OF HER C.P.A. THROUGH THE OTHER BROKERS. SHE HAD NO FURTHER CONTACT WITH FC. THE ARBITRATOR'S "CASE SUMMARY" INCORRECTLY STATES THAT FC ALLEGED UNAUTHORIZED TRADE BY FC; CLIENT MADE NO SUCH ALLEGATION. FC HAS BEEN IN CONTACT WITH THE NASD TO CONVERT THIS ERROR OVER THE LAST TWO YEARS WITH NO SUCCESS.
