IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: BANKERS LIFE SECURITIES, INC.

Allegations: Bankers Life and Casualty Company (BLC), an affiliated insurance company of Bankers Life Securities, Inc. (BLS), received a written client complaint and provided a copy to BLS on September 30, 2025. In the complaint, regarding the purchase of a BLC annuity in April 2025, the client alleges that the withdrawal limitations and terms of the annuity were not explained. The client alleges that they were under the impression they could withdraw the full amount in the first policy year, however, states that they recently learned that this is not possible. The client claims that the BLC annuity is not suitable for their needs and would not have proceeded with the purchase had they understood the limitations and as such is requesting to surrender the BLC annuity without penalty. BLC and BLS concluded that the representative's recommendation was suitable and in the client's best interest and the allegations were denied. While the BLC annuity is not a security and was issued by BLC, the Firm is reporting this complaint because the annuity was funded by the recommendation to liquidate securities by a financial representative of the Firm.
