IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: MWA FINANCIAL SERVICES, INC.

Allegations: Consumer alleges they and their spouse purchased a life insurance policy in 1988. Consumer alleges in the following years they were told the annual premium for the life insurance would be paid from the cash value of the insurance policy, so consumer assumed they did not need to make additional premium payments. The consumer stopped making additional premium payments in or around 1994. Consumer's spouse passed away in August 2023. Upon calling to make a claim, consumer alleges they found out the policy had been cancelled for failing to pay premiums. Consumer alleges they were not notified of the policy's cancellation. Consumer is alleging breach of contract, common law bad faith, statutory bad faith, engaging in unfair trade practices, negligence and fraud through statements and assertions.
