What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I DENY THE CLAIMANT'S ALLEGATIONS. THE CLAIMANT INVESTED IN NUMEROUS STRUCTURED NOTES OVER A PERIOD OF FIVE YEARS AND NEVER COMPLAINED ABOUT THEM, PARTICULARLY WHILE SHE WAS MAKING MONEY. PRIOR TO PURCHASE, I EXPLAINED THE KEY TERMS OF THESE INVESTMENTS TO THE CLAIMANT, INCLUDING RISK OF LOSS BASED ON THE ISSUER'S ABILITY TO PAY AT MATURITY, AND ALSO MADE SURE WRITTEN PROSPECTUSES WERE DELIVERED TO HER. I BELIEVE THAT, NOTWITHSTANDING THE ENSUING FINANCIAL CRISIS OF 2008, THESE INVESTMENTS WERE SUITABLE FOR THE CLAIMANT AT THE TIME OF PURCHASE. I WAS NOT A PARTY TO THE CASE AND WAS NOT ASKED TO CONTRIBUTE TO THE SETTLEMENT.

I DENY THESE ALLEGATIONS AS THE CREDIT RISK RELATING TO EACH ISSUER WAS DISCUSSED WITH THE CLIENT. THE DECISION TO PURCHASE THE INSTRUMENTS WAS MADE BY THE CLIENT, WITH HER HUSBAND, DURING A JOINT TELEPHONE CALL AND THE INVESTMENTS WERE SUITABLE FOR THE CLIENT AT TIME OF PURCHASE. THE CLIENT HAD BEEN INVESTING IN THIS TYPE OF INSTRUMENT SINCE 2003 AND IN FACT THE CLIENT'S ACCOUNT GREW EACH YEAR SINCE ITS INCEPTION IN 2003 UNTIL THE SUDDEN FINANCIAL CRISES IN 2008.
