IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement ALTHOUGH THE FIRM FOUND THAT [CUSTOMER] USED POLICY LOANS AND



PARTIAL POLICY WITHDRAWALS TO PAY SOME PREMIUMS, WHICH RESULTED IN THE CHANGES IN COVERAGE AMOUNT AND PERIOD HE WAS QUESTIONING, THE FIRM OFFERED TO CANCEL THE 1983 TRADITIONAL UNIVERSAL LIFE POLICY AND RESTORE VALUES TO HIS OLDER TRADITIONAL FIXED WHOLE LIFE POLICY. THE RESULTING SETTLEMENT WAS \$27,838.02. THE INITIAL SALE WAS BASED ON INTEREST RATES REMAINING CONSTANT OR THEREABOUTS. OBVIOUSLY, OVER THE PAST 14 YEARS THEY DROPPED AND THE POLICY DID NOT PREFORM AS EXPECTED.
