IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Sentence/Penalty:	I accepted a sentence of eighteen months of probation as part of a plea bargain. The entire sentence was successfully completed between 1999 and 2001.
Broker Statement	In the summer of 1998, my sister, Stacy McLeod (now Stacy Sipple) was on a break from med school and staying with my mother and me. She began pounding incessantly on my bedroom door. I came out of the room, and she went into an adjacent room. I kicked the door and walked away. After an argument in the kitchen afterward, my grown, 230-pound sister threatened me with violence. I



walked away back into my bedroom. My sister watched me from a distance across a large living room. I stood at the front of my room and showed her a knife that I had in my bedroom. I shouted across the living room for her to stay away, and I closed my bedroom door. No physical altercation ever took place.

My sister filed a police report, and I was arrested. I believe I was charged with two counts of aggravated assault. I do not have records or dates of the incident nearly 25 years later. I accepted a plea bargain in 1999 that resulted in adjudication being withheld for all charges.
