What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement**

I deny these allegations and believe them to be false. At no time, did I tell the client there would not be any fees related to this or any future accounts held at UBS. The client was provided compliance mandated documentation, when the estate account was opened that clearly states, on page 22 that UBS charges commissions on all stock, bonds and mutual fund trades in a brokerage account as well as custody fees. I believe this complaint is unfounded and reflects the executor's preference to not pay any fees for security transactions. Furthermore, the complaint was reviewed by Outside Counsel, hired to assess the merits of the complaint, and denied by letter dated 10/4/2021.
