### Broker Statement

This matter concerned the purchase of an annuity with an income rider that was restricted to customers aged 45 or older. Due to a clerical error, the client was entered into the firm's system as being 48 years old when she was really 43. Relying on that information, the financial advisor recommended the annuity with the income rider. After the issuer of the annuity cancelled the rider, the client sold the annuity for a net gain of over \$50,000, but alleged that she would have made more money if she had invested in something other than the annuity.
