IN JUNE OF 2009 A CIVIL LITIGATION WAS FILED BY THE FAMILY OF CUSTOMER AGAINST SEVERAL PARTIES INCLUDING IRA TURPIN. THE FORM U4 ORIGINALLY FILED BY RAYMOND JAMES INCLUDED TWO ALLEGATIONS NEVER ACTUALLY MADE AGAINST MR. TURPIN. THE ONE ALLEGATION MADE AGAINST MR. TURPIN WAS ALSO MADE AGAINST RAYMOND JAMES. MR. TURPIN WAS DISMISSED OF THIS ONE ALLEGATION WITHOUT PREJUDICE PRIOR TO SETTLEMENT BY RAYMOND JAMES. THE CLERK OF COURT LATER ENTERED PLAINTIFF CLAIMS AGAINST MR. TURPIN OF TURPIN MARTIN POWELL, LLC. AND RAYMOND JAMES FINANCIAL SERVICES, INC. AS SETTLED AND DISMISSED WITH PREJUDICE.

THE CIVIL LITIGATION WAS FILED AS A RESULT OF FRAUD COMMITTED BY PEOPLE CLAIMING TO BE THE HEIRS TO THE ESTATE. THE RIGHTFUL HEIRS TO THE ESTATE FILED A CIVIL LITIGATION IN AN ATTEMPT TO GET THE MONEY BACK. THE CASE AGAINST THE PARTIES WHO MISREPRESENTED THEMSELVES AS HEIRS IS SCHEDULED FOR TRIAL IN SEPTEMBER OF THIS YEAR.
