**Allegations:** ATTORNEY ALLEGES THE CLIENT PURCHASED A 1994 VARIABLE LIFE INSURANCE POLICY BASED ON THE AGENT'S REPRESENTATION THAT HE WOULD PAY APPROXIMATELY \$21,000 TO \$22,000 EACH YEAR AND THE PREMIUMS WOULD BE INVESTED INTO A PORTFOLIO OF STOCKS AND BONDS TO INCREASE THE OVERALL VALUE OF THE POLICY. ATTORNEY FURTHER ALLEGES THAT AFTER MAKING REGULAR PAYMENTS FOR APPROXIMATELY 10 YEARS, HIS CLIENT WAS INFORMED BY THE AGENT THAT HE NO LONGER NEEDED TO MAKE REGULAR PAYMENTS, AS THE POLICY COULD BE PROPERLY MAINTAINED UNTIL HE WAS NEARLY 90 YEARS OLD. ATTORNEY ALLEGES THE CLIENT HAS NOW BEEN INFORMED THAT THE POLICY WAS CANCELLED. CLIENT IS REQUESTING FOR HIS POLICY TO BE REINSTATED IN FULL. DAMAGES UNSPECIFIED.
