IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	<p>This all occurred when traveling from LAX to Atlanta for a very early morning flight. I had just passed through the TPS checkpoint after placing my carry-on luggage & personal items in the provided gray containers, and then on the conveyor belt for xray and inspection. Not knowing there was a TPS desk/officer in proximity as I was unfamiliar with the airport I continued to purchase breakfast intending on turning in the ring at my gate. I was approached by two officers while in the fast food restaurant and fully complied with officers after being questioned about anything I had that didn't belong to me. The ring was promptly returned to the owner within 15 minutes.</p>
