IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

In May of 2014, I was visiting New Jersey with some of my friends at the time, and was a passenger in the vehicle being driven by someone else. The individual that was driving me, had, unbeknown to me, brought with him in a backpack in the back of the vehicle, Marijuana, a kitchen scale, and a knife purportedly for fishing. He was speeding on the highway and pulled over by a patrolman, who subsequently performed a field sobriety test on the driver. He then requested to search the vehicle and was declined, but saw a suspicious box in the car and detained all present. Later on a search request was approved by the local court and a search of the vehicle revealed the previously disclosed items. After this was revealed a warrant for arrest was issued for all present, including myself, and all charges, including these two felony charges, possession of a controlled substance with intent to sell (due to the scale), and possession of a controlled dangerous weapon were filed against everyone present. The driver of the vehicle, who was the owner of all applicable items found, claimed ownership and responsibility for the items and all of the charges were dropped against myself as I had done nothing wrong.
