### What is included in a IAPD report?

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

This was a momentary lapse of judgement, but by everyone's admission, primarily social services of the state of New Jersey, I was an exception and not the norm, and in no way was this related to anything financial. I was charged with 2nd degree child endangerment and possession. Ultimately, the possession charge was removed and I was convicted of 4th degree child endangerment.</p>
