### Where did this information come from?

**Broker Statement**

While working at a local sporting goods store, I was questioned by management about the wrongful taking of personal property. I was accused of possessing personal property taken by other employees. I returned and paid for all times that were taken/given/sold to me by other employees. I should have known better than to believe that the items were purchased at a discount and were non-returnable items. I believe the felony charge was a result of all property taken by all employees, therefore the charges against me were reduced to a misdemeanor - petty theft. This was a foolish mistake that occurred as a late teenager several decades ago.
