What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

This judgement entered against me was by Express Recovery Services, acting on behalf of Granger Medical Clinic, for outstanding medical bills. I received the medical bills in 2017, while I was uninsured. I failed to pay the debt back to the medical office, and it was sent to a collections agency to collect, and then eventually entered as a judgement. I have a payment agreement with Express Recovery Services law office, Edwin Parry Law, to pay the debt back by March 2022, and they will not pursue any post judgement liens, or action. I will continue to pay off this debt, and resolve the issue. It is the only judgement I have ever received against me.
