IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations: Prior to becoming an employee of the applicant, Michael Casey, then an employee of Lowry Hill Investment Advisors, Inc., was subject to a complaint (alongside other parties) that alleged: breach of fiduciary duty, negligent misrepresentation, fraud, professional negligence, negligent supervision, fraudulent inducement to enter into contract and breach of contract.

The complaint was filed on March 15, 2002. The complaint alleged that the defendants failed to appropriately manage a single/concentrated stock position over which they had discretionary authority. The defendants denied the allegation, asserting that the plaintiffs had exclusive authority over the stock position in question.

The applicant is not aware of the final settlement amount agreed upon by the parties. Mr. Casey was not required to contribute any money to the settlement and was held harmless by Wells Fargo for all costs related to the defense of the case.
