**Allegations:** During the course of Sarah A. Alexander's employment with Fidelity Brokerage Services, LLC, CRD No. 7784 as a sales representative and Fidelity Personal and Workplace Advisors, CRD No. 288590 as an investment adviser representative, the two firms are collectively referred to as Fidelity, and while licensed as either a sales representative and/or an investment adviser representative, Alexander took photos of her workstation on at least six (6) occasions. At least four (4) of those photos included confidential and/or personal client information that was contained on the Fidelity account information page on her computer monitor. Alexander shared the photos with at least two (2) people who were neither employed by Fidelity nor authorized to receive client information.

The licensee failed to observe high standards of commercial honor and just and equitable principles as a sales representative (FINRA Rule 2010) in violation of Rule 51-4.7(H)(1) and engaged in dishonest and unethical conduct as an investment adviser representative by disclosing the identity, affairs, or investments of clients in violation Rule 51- 4.8(IA)(N).
