What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement While I was studying abroad, a charge was brought against me by an ex girlfriend for 2nd degree sexual assault. Upon my return to the U.S.A., I got in contact with my lawyer and over the next year and a half we looked to fight the charge. As the process was drawing out due to COVID-19 coupled with mounting lawyer fees I did not want to burden my family with, I ultimately plead NOLO CONTENDERE to an amended charge of 2 simple assault misdemeanors instead. The penalty was 2 years total unsupervised probation, 20 hours of community service, a no contact order, and a donation to be made to a victim's fund. All aspects of this sentence have been satisfactorily met.
