IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement AFTER DECIDING TO BE IN THE BUSINESS OF PROVIDING INVESTMENT



ADVICE FOR COMPENSATION, IAR FORMED A NEW COMPANY AND APPLIED FOR REGISTRATION AS AN INVESTMENT ADVISER IN JUNE 2024. DURING THE APPLICATION PROCESS, APPLICANT NOTIFIED THE STATE THAT AFFILIATES OF THE APPLICANT HAD PROVIDED INVESTMENT ADVICE TO SOME FRIENDS AND FAMILY WITHOUT COMPENSATION, AND THAT TWO FRIENDS HAD CHOSEN TO PAY THE AFFILIATE EVEN THOUGH THEY WERE NOT REQUIRED TO DO SO. AFFILIATES HAD NOT REALIZED THAT RECEIPT OF THESE VOLUNTARY PAYMENTS FROM FRIENDS WOULD BE DEEMED BY THE STATE AS ACTING AS AN INVESTMENT ADVISER OR INVESTMENT ADVISER REPRESENTATIVE IN CONTRAVENTION OF STATE REGULATIONS. THE PAYMENTS WERE THEN RETURNED IN FULL. THE NEW ENTITY'S APPLICATION FOR RIA REGISTRATION WAS APPROVED FOLLOWING EXECUTION OF THE CONSENT ORDER.
