What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement	On June 30, 2004, I was involved in a traffic stop, and during this traffic stop, I provided my valid identification which included my correct name, date of birth and address. To my recollection, the officer was asking me for my middle name, as it did not appear on my drivers license. At the time, the State of Georgia did not require middle name to be provided to obtain a drivers license, therefore it was not provided at the time I applied for my license. I did provide the information that was



requested by the officer. However, there is a discrepancy in the way my middle name is spelled on my birth certificate and social security card (Cilette) and the "correct" spelling (Cillete). This resulted in the officer stating that I provided false information. I did later go to court regarding this matter, and the case was dismissed.
