IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement

I owned two homes, one was my primary residence and the other was a rental property. My rental property was vacant for an extended period of time, during which I was paying both mortgages out of my military salary. Unfortunately, I was not able to maintain this and resorted to credit cards to make ends meet at home. Eventually the balances on my credit cards became too high that I wasn't able to make the minimum payments, both mortgages, and still pay my regular bills. I sought financial advice, followed by legal counsel. I was advised to file for bankruptcy and let go of the rental property. I was able to reaffirm on my primary residence and retain it. The case was closed and there is no further actions.
