IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

I HAD SUBMITTED APPOINTMENT PAPERWORK PROVIDED BY THE MANAGER OF THE ANNUITY COMPANY AT ISSUE AND HAD FULLY EXPECTED IT TO BE PROCESSED EXPEDITIOUSLY. I ALSO CONFIRMED THAT MY BROKER-DEALER HAD A SELLING AGREEMENT FOR THE PRODUCT. I HAD MANY HUNDREDS OF CLIENTS AFFECTED BY A CHANGE IN THEIR RETIREMENT PLAN AND AS THEIR REGISTERED REPRESENTATIVE WAS RESPONSIBLE TO MAKE SURE I COULD ASSIST THEM WITH THEIR TRANSITION. I MADE INITIAL CONTACTS WITH A FEW OF MY CLIENTS BUT AS SOON AS I LEARNED THAT THE APPOINTMENT PROCESS WAS NOT PROCEEDING, I VOLUNTARILY STOPPED MEETING WITH MY CLIENTS. NO TRANSACTIONS OCCURRED. MY UNDERSTANDING WAS THAT THE OTHER ADVISOR WAS ALREADY SOLICITING HIS OWN 403(B) CLIENTS WITH THE ANNUITY COMPANY THROUGH THE BROKER-DEALER WITH WHICH HE IS REGISTERED. I DID NOT DISCUSS A POTENTIAL COMMISSION OR FEE-SHARING ARRANGEMENT.
