IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Sentence/Penalty: The penalty was 3 months of outpatient drug therapy in Pasadena, CA. It was under Prop 36, where by doing the outpatient therapy I would have the charges and incident removed from my records permanently. The approximate start of the treatment was September 2010 and lasted until sometime in December 2010.

Broker Statement I had 2 mdma pills on me and was headed to a friend's house when I was caught with the 2 pills and charged with transportation of them. I went to court, took responsibility for my action, and the prosecuting DA determined that I was eligible for the case to be removed from my records if I did 3 months of outpatient treatment. When filing for my insurance license in 2024, the courts found no record of the incident. Which is why I do not have exact dates, outside of finding an email to family around the date of being charged.
