### What is included in a IAPD report?

### Where did this information come from?

Again, I am the owner, president, CEO, principle, etc. This is an LLC for expense and part-time staff payroll related to running my Knights of Columbus Insurance Practice. My time spent on this company is limited to the administrative activities of managing my Knights of Columbus Insurance Practice: expenses (mailing/shipping materials, mobile phones, administrative assistant payroll, etc.)

Neither LLC is associated with any registration as a Broker-Dealer, Agent, Investment Advisor, or Investment Advisor Representative.

A third outside business activity for this purpose is my appointment with Knights of Columbus Insurance as an Insurance Producer, non-investment related, life insurance, selling life insurance, long term care, disability income and annuities, Start Date: (4/2018), 80 hours a month. Hinsmap, LLC is not connected to Knights of Columbus, it is simply a way for me to track expenses for tax purposes separate from my personal finances. Knights of Columbus pays me directly as an individual, they will not pay an LLC.
