What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: CUSTOMER, OF WHICH [FAMILY MEMBER], A FORMER TECHNOLOGY EXECUTIVE, AND HIS WIFE WERE THE TRUSTEES, OPENED AN ACCOUNT WITH A \$3 MILLION DEPOSIT IN MARCH 2000 AND PURCHASED APPROXIMATELY \$850,000 OF TECHNOLOGY STOCKS WHICH SUBSEQUENTLY DECLINED IN VALUE. THE ACCOUNT WAS CLOSED IN NOVEMBER 2002, AND IN MAY 2005 AN ARBITRATION CLAIM WAS FILED ALLEGING THAT THE FIRM AND THE REGISTERED REPRESENTATIVE WERE RESPONSIBLE FOR THE LOSSES IN THE ACCOUNT.
