What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Sentence/Penalty: The case was resolved as a conditional discharge-2 years of good behavior (up to 365 days of conditional jail). The conditions as described by the court have been followed and completed within the required timeframe, starting 10/25/2018 and ending 10/25/2020. This record is eligible for expungement as of 10/25/2025, and my representation has begun the filing process as of 11/12/2025.

Broker Statement

I struggled with alcohol addiction in my younger years. This led me to a significant other who also struggled and introduced me to cocaine. One night while under the influence, we got into a loud argument in which the neighbors overhead and called the police. The police arrived and put me in handcuffs and found the controlled substances in our possession. I was charged with 4th degree domestic violence minor injury, possession of a deadly weapon (a pocketknife I carried with me at the time), and possession of a controlled substance, 1st and 2nd degree.

I eventually entered a rehabilitation program at Landmark in Louisville, KY and have been sober since. This has been reported to Kentucky's Department of Insurance who subsequently issued my insurance licenses. The record is eligible for expungement as of 10/25/2025 and my legal representation has begun the process to expunge the record.
