IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement This was an occurrence when I was a student in college. During this occurrence, a window was broken and as a result another individual and myself were arrested after the fact. Because the cost of the window and the labor to replace it exceeded \$500, I was charged with criminal damage to property in the 2nd degree, which Georgia considers a felony. The charge was amended to trespass which is a misdemeanor in Georgia. Ultimately this was settled under a conditional discharge and has since been finalized. The finalized discharge stated that I was discharged without adjudication of guilt; the discharge shall completely exonerate me of any criminal purpose; the discharge shall not affect my rights or liberties; I shall not be considered to have a criminal conviction; and I cannot be disqualified in an application for employment to office in either public or private sectors.
